LEADERSHIP ROLES

Board Committees - Board member chairs committee; work centers on activities of the Board

Budget and Finance:

Board members attend meetings in the spring to set budget priorities and review the college's proposed budget before submitting to the Tax Supervising and Conservation Commission (TSCC).

Committee chair meets with the Vice President of Administration and Finance at least quarterly to review the college's budget status.

Community Engagement:

Board members track their community involvement related to the college, and report action monthly to the Executive Assistant to the Board.

Committee chair meets with the MHCC Board Chair and Vice Chair to develop strategies for Board engagement in the community.

Board members take part in specific outreach efforts, including attending meetings and events.

Board Liaisons – Board member(s) participates by sharing information; other group is responsible for the work

<u>Audit</u>: Attend two meetings per year with the external auditors; provide proactive oversight for the financial compliance reporting, and risk management processes and disclosure by thoroughly reviewing the audit report; limit two Board members per committee.

NOTE: In Policy 1065, we currently list this as an advisory committee of the Board, though the requirements suggest the Board member(s) roles on the committee are in a liaison capacity.

<u>Head Start</u>: Attend two Head Start Policy Council meetings during the year; speak at one Head Start staff meeting; participate in Head Start self-assessment; provide Head Start information to MHCC Board.

NOTE: Dr. Kisa is reviewing the federal requirements, additional duties may be added based on her review

MHCC Foundation: Attend regular MHCC Foundation board meetings and share Board of Education information; attend Foundation events including the annual auction; provide MHCC Foundation information to MHCC Board.

<u>Oregon Community College Association (OCCA)</u>: Attend regular OCCA board meetings, workshops, conferences, typically held October, November, February, and May; consult with MHCC Board members on relevant OCCA topics and represent MHCC on the OCCA Board; provide OCCA information to MHCC Board; advocate for legislation in support of the college, by meeting with, emailing or calling legislators.

<u>Oregon School Board Association (OSBA)</u>: Attend regular OSBA board meetings; consult with MHCC Board members on relevant OSBA topics and represent MHCC on the OSBA Board; provide OSBA information to MHCC Board.

Volunteers - Optional opportunities for Board members to participate on college committees; college is responsible for the work; limit two Board members per committee.

<u>Distinguished Teaching Awards Committee</u>: Review nominations during spring term and make recommendations as part of the committee.

<u>Outstanding Support Staff Awards Committee</u>: Review nominations during spring term and make recommendations as part of the committee.
